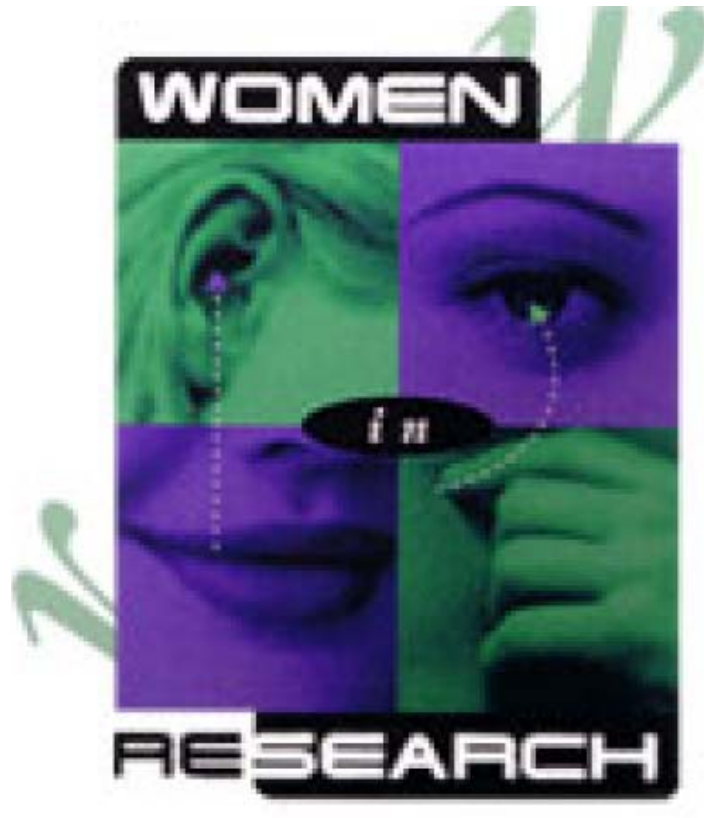

**Elizabeth M Deane**  
**Dean, Division of Environmental & Life Sciences**  
**Macquarie University**

**Profile and recent publications (1998 – 2003)**

Deane is currently Head of Division of Environmental and Life Sciences at Macquarie University. Prior to this she consistently held academic leadership positions for the past fifteen years as Head of Department and Head of School at the university of Western Sydney. She has initiated and led the development of a number of educational programs, including the B. Sc (Biological Sciences), M. Clinical Sciences, M. Reproductive Medicine. B Liberal Studies all at UWS and the B. Health at Macquarie. Deane is also currently a Director of Biomed North, a consortium aimed at increasing the interface between university and hospital research and industry to deliver commercial outcomes. She has had significant experience in attracting funding for major projects and seeing them through to completion. These include two Evaluation and Investigation Program Grants, two DETYA Teaching and Learning Grants and two current Science Lectureship grants. Of the latter one of these projects is concerned with developing and delivering a program in Wildlife and Habitat Management for practitioners. This project has involved constructing a consortium of experts from agencies concerned with habitat and wildlife to contribute to the program.

Deane is an active researcher in the area of marsupial biology and management. She is a member of the executive for the CRC for Conservation and Management of Marsupials and as such has had broad experience in contributing to the direction of research programs in wildlife management. She is currently the recipient of an ARC SPIRT grant with Perth Zoo, and two ARC Linkage grants one with Taronga Zoo, the other with TGR Biosciences, Adelaide. These grants are directed at developed better management tools for captive and wild populations of marsupials and in examining innate defence strategies in these mammals. As Head of Division, Deane is also responsible for the effective operation of the Macquarie University Fauna Park. This responsibility includes both financial management as well as ensuring ethical compliance and management of the research population.

**Professor Vicki Sara, FAA, FTSE**  
**Chief Executive Officer**

**Australian Research Council**



Professor Vicki Sara was appointed Chief Executive Officer of the Australian Research Council in July 2001. From September 1997 to June 2001 she was the Chair of the Council and member of the Prime Minister's Science Engineering and Innovation Council (PMSEIC). She is Chair of the Bureau of Meteorology Advisory Board, and a member of the CSIRO Board, the Cooperative Research Centres Committee, and the Rio Tinto Foundation for a Sustainable Minerals Industry. She is a Fellow of the Australian Academy of Science, and the Australian Academy of Technological Sciences and Engineering. Professor Sara was appointed Vice-Chair of the OECD's Global Science Forum in 1999, and member of the Advisory Board of the APEC R&D Leaders' Forum in 2002.

Professor Sara returned to Australia in 1993 following a research career at the Karolinska Institute in Stockholm.

After receiving a UNESCO postdoctoral fellowship to Sweden, Professor Sara held various research positions at the Karolinska Institute, Stockholm, heading the Endocrine Pathology Research Laboratory. Whilst at the Institute she isolated a growth hormone factor responsible for regulating foetal brain development.

She was awarded the Rolf Luft medal in 1993 for excellence in endocrine research by the Karolinska Institute in recognition of her work, and also received the Sir John Eccles Award from the NH&MRC in 1994. She was appointed as foreign Professor of Karolinska Institute in 1995.

Prior to her appointment to the ARC, Professor Sara was Dean of Science at Queensland University of Technology (QUT). Other appointments at QUT included Head of School of Life Science, and Director of the QUT-based Cooperative Research Centre for Diagnostic Technologies.

**Keynote Speaker**  
**Professor Gail Whiteford**  
**Charles Sturt University**



**Professor Gail Whiteford** currently holds the Chair of Occupational Therapy at Charles Sturt University in Albury, NSW Australia. She is also the Centre Director of the university's newest research centre, Research Into Professional Practice, Learning and Education: RIPPLE, she also holds positions as an Adjunct Professor at Dalhousie University in Canada and at James Cook University in Queensland. She has published internationally in the occupational therapy literature and is member of the editorial board of the Journal of Interprofessional Care based in London and is the Associate Editor of the Australian Occupational Therapy Journal. Gail is actively involved in research at her own university, currently undertaking a pilot study with Kosovar refugees and an intercultural competence study using critical incident methodology in Vietnam. She is the

Senate Nominee to the Research Management Committee and is convenor of the Women's Research Forum.

**Professor Amy Zelmer**

Amy Zelmer's early career was in community health, nursing, adult education and university administration in Canada and India. She moved to Central Queensland in 1988 to become Principal Lecturer at the Capricornia Institute of Advanced Education and worked through the multiple changes of programs and institution to become the Foundation Professor and Dean for what became the Faculty of Health Science at Central Queensland University. Since "leaving the payroll" (some would say "retiring") in 1996 Amy has continued to supervise some post-graduate students, worked as a mediator and Joint Regional Director for the Queensland Anti-Discrimination Commission, been a member of two IDP delegations to the People's Republic of China, volunteered as an adult literacy tutor, become heavily involved with the Cochrane Collaboration (health research), prepared materials for Project Gutenberg and provided volunteer services for the CQU special Collections. She has also indulged in her interest in travel, survived a broken femur (which provided an experience of cross-cultural health care), struggled with tai chi and learned to swim!

## **BECOMING SYLVIA PLATH: LITERARY CRITICISM AND THE SELF**

**Ann-Marie Priest**

Central Queensland University, Rockhampton

The poetry of Sylvia Plath is preoccupied with the nature of the self. Plath explicitly drew on her own experiences of breakdown, attempted suicide, electric shock therapy and psychoanalysis in her depictions of the self as both fragmented and unified, annihilated and triumphantly reborn. Since her suicide at the age of 30, many critics have become obsessed with the search for the "real" Plath among the many, often competing identities evident in her poetry, her journals, her letters, and her thinly disguised autobiographical novel, *The Bell Jar*. In fact, Plath criticism is often extraordinarily personal. As Cynthia Sugars points out, critics seem to identify with Plath more deeply and completely than they do with other writers, projecting on to her the fragments of their own identities. As well as the many biographies of Plath, countless memoirs from those who knew her, and several speculative tomes on the relationship between Plath and her estranged husband, Ted Hughes, there have recently been a number of "novelisations" of Plath's story in which writers re-imagine Plath's life, putting themselves inside her head. This paper seeks to explore the ways in which the reader's own self is at stake in approaching Plath's life and work. It will consider both Plath's own ideas and representations of the self, and the intensely personal investment many critics make in their research into Plath's work. This exploration will be framed by my own reflections on the abiding fascination of Plath's life and work for me, and the ways in which they have become an important part of my research into twentieth-century representations of subjectivity.

### **Sylvia Plath, literary criticism, 20th-century poetry, biography, subjectivity**
